HE&R is not responsible for Scratch-Off Cards that are lost, late, illegible, stolen, incomplete, invalid, unintelligible, or misdirected, or for problems of any kind whether mechanical or human. HE&R is not responsible for late, lost, damaged, misdirected, illegible or incomplete entries, prize claims, or requests. HE&R retains the right to disqualify any entry that has been incorrectly scratched and/or submitted. - 9. BINDING ARBITRATION/DISPUTES.
